To: ALL RECOGNIZED ORGANIZATIONS AND DEPUTY REGISTRARS

Subject: NOTIFICATION FOR SURVEY / AUDIT ATTENDANCE BY RECOGNIZED **ORGANIZATIONS** 

- 1. Reference
  - Form F054 Notice for Survey/Audit Attendance by RO, as amended 1.1
- 2. Purpose
  - This Marine Circular informs all authorized Recognized Organizations and appointed Deputy Registrars about the procedure to be followed for the Survey/Audit attendance by the Recognized Organization for any Palau flagged vessel.
- 3. Applicability
  - 3.1 This Marine Circular applies to all Recognized Organizations for all Surveys / Audits required to be carried out by Recognized Organizations duly authorized by the Palau Flag Ship Registry Administrator.
- 4. Procedure
  - 4.1 The Recognized Organization is requested to notify the Flag Administration by sending the Form F054 - Notice for Survey/Audit Attendance by RO to technical@palaureg.com, PRIOR the intended Survey/Audit attendance, preferably not later than 3 days in advance.
  - The Form F054 Notice for Survey/Audit Attendance by RO shall be dully filled, 4.2 and all required information shall be duly reported to the Flag Administration.
  - Any Surveys/Audits carried out by a RO found not in compliance with this Marine Circular, shall be considered as invalid and any relevant documentation and/or certificates issued on behalf of the Republic of Palau shall be considered invalid.
- 5. Entry into Force
  - The amended procedure of this Marine Circular enters into force November 30th, 2022.
