Subject: Special arrangements set up by MTA for effectively render services during the COVID-19 pandemic

1. Introduction

1.1 In light of the recent global developments caused by the novel coronavirus COVID-19 and the measures announced by the Georgia Government to halt the spread of the pandemic, LEPL Maritime Transport Agency (MTA) will not allow visitors to enter its premises from 23 March till 21 April 2020 in accordance with order N03 of the Director of MTA.

2. Ships Registration for ships engaged in domestic navigation

2.1 In accordance with the above mentioned order, registration of ships engaged in domestic navigation will be discontinued until 21 April 2020.

2.2 MTA will, for not more than 2 Month and in case of expiry, automatically extend the validity of registration and radio station certificates for ships less than and more than 100 GT engaged in domestic navigation.
