Dear Secretary-General,

The Kingdom of Denmark presents it compliments to the Secretary-General of the International Maritime Organization and is honoured to bring to the attention of you a matter involving Danish registered vessels calling at various ports around the world.

This letter confirms and announces that from 24 June 2016, Denmark will begin issuing electronic ship certificates to vessels flying the Danish flag. The certificates will carry an electronic coat of arms, the stamp of the Danish Maritime Authority, a signature of an authorized inspector as well as a unique tracking identification number. The certificates are protected from alteration or tampering through encryption and use of a digital signature. This means, that the certificates are in compliance with FAL.5/Circ.39 (Guidelines for the use of electronic certificates).

Further information found on the following page is provided to the Secretariat of the International Maritime Organization with our humble request for the Secretariat to issue a circular for notification and information of all Member States.

The Kingdom of Denmark avails itself of this opportunity to renew to the Secretary-General of the International Maritime Organization the assurances of its high consideration and esteem.

From June 24 2016, the Kingdom of Denmark will issue ship certificates in electronic format.

The certificates contain the coat of arms in blue in the upper left corner, an electronic signature of an authorized inspector together with the stamp of the Danish Maritime Authority.

For the purpose of checking the validity and authenticity of the ship certificates, all certificates have a unique tracking identification number, for example tracking no.: 4168728-3705325-07-03-2016. To verify this unique tracking identification number and the certificate in general, please visit the webpage of the Danish Maritime Authority: www.dma.dk. Alternatively, please contact the Danish Maritime Authority by email sfs@dma.dk or 24/7 by phone +45 91376000.

The certificates are transmitted electronically and they are protected by encryption and digital file signature from alteration or tampering. The certificates can be presented to inspectors and other relevant third parties either electronically on a computer screen or in a printed colour version.

An example of a certificate furnished with a unique tracking identification number is attached. Since this example cannot be reproduced and distributed in colour, labels have been added to highlight the specific security measures.

Also attached is a copy of our formal Flag State letter, which contains the same information as provided above and which is intended to be carried on board ships to facilitate Port State Control. This letter is also available from the webpage of the Danish Maritime Authority.

Please note that certificates issued by Recognized Organizations on behalf of the Danish Maritime Authority may either be presented in an electronic format in accordance to the FAL.5/Circ.39 or still be presented in an original paper format.
