



BERMUDA MERCHANT SHIPPING NOTICE

Seafarer's Medical Certification

2021-029

Application

Conducting Bermuda Seafarer's medical examinations and the issuing of medical certificates for Bermuda are governed by the provisions of the above International Conventions and the Bermuda Statutory Instruments.

Shipowners, managers, operators and masters must ensure that prior to beginning work on board a Bermuda ship, the seafarers hold a valid medical certificate attesting that they are medically fit to perform the duties that they are to carry out at sea.

Summary

Bermuda is a MLC 2006 ratified Maritime Administration.

The 2012 amendments to the Merchant Shipping Act 2002, gives effect to the provisions of the Maritime Labour Convention 2006, in Bermuda.

The Merchant Shipping (Medical Certification of Seafarers) Regulations 2013 stipulates, for working on board a Bermuda ship, seafarers shall hold Medical Certificates issued by a qualified medical practitioner as described below:-

- a. A qualified medical practitioner in a country which is approved by the Minister and who is authorised by that country to issue such certificates, and is listed in the register of recognised medical practitioners maintained by that country; ***(See Appendix I - The List of Countries Approved by the Minister)***
- b. A qualified medical practitioner authorised by the Minister for the purpose of issuing Bermuda Seafarer's Medical Certificates; or ***(See Appendix II - The List of Doctors Authorised by the Minister)***
- c. A qualified medical practitioner authorised by the Maritime and Coastguard Agency, United Kingdom (UK) to issue an ENG1 certificates in accordance with the UK requirements for such certificates. ***(Refer to UK MCA Approved Doctors List).***
