Dieses Rundschreiben informiert über die Änderung der STCW Trainings- und Qualifikationsanforderungen für **Fahrgastschiffe**.

Anwendung

Die Änderungen gelten ab dem **01. Juli 2018** für alle Fahrgastschiffe, für die Regel V/2 STCW anzuwenden ist.

Inhalt

Die neue Regelung bezieht sich auf Anforderungen für unterschiedliche Dienstränge, Notfallaufgaben und die Dokumentation der Nachweise. Weitere Informationen sind der angehängten Matrix zu entnehmen.

Zusatz für Fahrgastschiffe in der Inlandsfahrt, die keine Ro-Ro-Fahrgastschiffe sind:

Für die Besatzungsmitglieder ist zusätzlich und unabhängig von der Regel V/2 STCW eine Unterweisung unter Berücksichtigung der Anforderungen der IMO-Entscheidung A.865(20)¹ an Bord durchzuführen und zu dokumentieren.

This circular informs about changes to the STCW requirements for training and qualification for **passenger ships**.

Application

The changes apply to all passenger ships subject to Regulation V/2 STCW from **01 July 2018**.

Content

The new regulation specifies training and qualification requirements and documentary procedures. Further information can be gathered from the attached matrix.

Note for German passenger ships other than ro-ro-passenger ships sailing on national voyages only:

Crew members shall receive **additionally** and independently of STCW Regulation V/2 a documented familiarization training, taking into account the requirements of the IMO Resolution A.865 (20).²
