MERCHANT MARINE CIRCULAR MMC-255

To: Ship-owners/Operators, Company Security Officers, Legal Representatives of Panamanian Flagged Vessels, Panamanian Merchant Marine Consulates and Recognized Organizations (ROs).

Subject: Maritime Labour Convention, 2006 (MLC, 2006) - Authorized Recognized Organizations.

Reference: Resolution JD-No 019-2005 of November 24th, 2005.

Resolution No. 106-25-DGMM of May 4th, 2012.

1. PURPOSE:

- 1.1. The purpose of this Circular is to inform our users that the Directorate General of Merchant Marine has decided to delegate to the Recognized Organizations the issuance of the Maritime Labour Certificate, the Declaration of Maritime Labour Compliance Part II and the provisional certificate, in accordance to Rule 5.1.2 of the Maritime Labour Convention. Through Resolution No. 106-25-DGMM of May 4th., 2012, this Directorate General of Merchant Marine has invited all RO's to apply for the authorization to issue the above-mentioned certificates.

- **3.** The surveyor of the ROs duly authorized by this Administration (listed above), must be qualified on the application of the MLC, 2006.
- **4.** The General Directorate of Merchant Marine shall regulate all matters related the issuance and validity of the Maritime Labour Certificate (interim and full) through the Circular MMC 269.
- **5.** All the Maritime Labour Certificate and the Declaration of Maritime Labour Compliance Part II must comply with the Appendix A-5II of the MLC, 2006.
- **6.** The Classification Societies and the Recognized Organizations that are authorized after the publication of this Circular shall be included in the current list.
