Amendment 1-1

Chapter 13 WATERTIGHT BULKHEADS

13.3 Watertight Doors

13.3.7 Source of Power

Sub-paragraph -3 has been amended as follows.

1 The remote controls, indications and alarms required in 13.3.4 to 13.3.6 are to be operable in the event of main power failure.

2 Electrical installations for devices specified in -1 except those of a water-proof type approved by the Society are not to be under the freeboard deck.

3 Cables for devices specified in -1 are to comply with the requirements of 2.9.11-<u>32</u>, Part H of the Rules.

Chapter 24 TANKERS

24.9 Structural Details

Paragraph 24.9.4 has been added as follows.

<u>The arrangement and scantlings of the supporting structures of the independent prismatic tanks</u> are to be at the discretion of the Society.
