## AMENDMENT TO THE RULES FOR THE SURVEY AND CONSTRUCTION OF SHIPS OF FIBREGLASS REINFORCED PLASTICS

“Rules for the survey and construction of ships of fibreglass reinforced plastics” has been partly amended as follows:

### Chapter 2 CLASS SURVEYS

#### 2.2 Classification Survey during Construction

##### 2.2.4 Inspections during Construction

Sub-paragraphs -2 and -3 have been amended as follows.

1 (Omitted)

2 The presence of the Surveyor is required at the following stages of the work in relation to hull~~s~~. To implement surveys specified otherwise by the Society, in lieu of traditional ordinary surveys where the Surveyor is in attendance, the Society may approve other survey methods which it considers to be appropriate in the following cases.

((1) to (8) are omitted.)

3 With respect to the work in relation to machinery and equipment, the presence of the Surveyor is to be in accordance with the requirements in 2.1.4, Chapter 2, Part B of the Rules for the Survey and Construction of Steel Ships. To implement surveys specified otherwise by the Society, in lieu of traditional ordinary surveys where the Surveyor is in attendance, the Society may approve other survey methods which it considers to be appropriate.

## AMENDMENT TO THE GUIDANCE FOR THE SURVEY AND CONSTRUCTION OF SHIPS OF FIBREGLASS REINFORCED PLASTICS

“Guidance for the survey and construction of ships of fibreglass reinforced plastics” has been partly amended as follows:

### Chapter 2 CLASS SURVEYS

#### 2.2 Classification Survey during Construction

Paragraph 2.2.4 has been added as follows.

##### **2.2.4 Inspections during Construction**

**1** The wording “items specified otherwise by the Society” and the wording “survey methods which it considers to be appropriate” in **2.2.4-2(1) and (3) of the Rules** mean to be in accordance with the following (1) and (2) respectively:

(1) The wording “items specified otherwise by the Society” means surveys of the tests specified **in 2.2.4-2(1) and (3) of the Rules.**

(2) The wording “the Society may approve other survey methods which it considers to be appropriate” means survey methods which it considers to be able to obtain information equivalent to that obtained through traditional ordinary surveys where the Surveyor is in attendance.

**2** The wording “items specified otherwise by the Society” in **2.2.4-3 of the Rules** means surveys of the tests specified in **B2.1.4-1(1) and -8, Part B of the Guidance for the Survey and Construction of Steel Ships** and the wording “the Society may approve other survey methods which it considers to be appropriate” means to be in accordance with **-1(2).**

#### EFFECTIVE DATE AND APPLICATION

1. The effective date of the amendments is 1 July 2021.
