Guidance for the Survey and Construction of Inland Waterway Ships

Reason for Amendment

Requirements for coal burning installations on ships burning coal as fuel for main and essential auxiliary boilers regarded as machinery installations with novel design features were specified in the Annex D1.1.3 of Part D of the Guidance for the Survey and Construction of Steel Ships.

Since coal burning installation types such as pulverized coal burning systems, fluidized bed firing systems or slurry systems of coal-oil mixtures were in development stage for marine propulsion systems around 1981, the annex was specified as the technical guidance at that time.

However, the technical requirements of the annex have never since been amended and there is no prospect of ships burning coal as fuel being built in the future.

Accordingly, requirements related to coal burning installations were deleted as a part of a comprehensive review of the NK Rules.

Outline of Amendment

Deleted Annex D1.1.3 of Part D of the Guidance for the Survey and Construction of Steel Ships as well as all requirements making reference to the annex.
