船級証書書式改訂(設備証書廃止/船級証書への統合)について

各位

船級証書、設備証書の管理及び運用の簡易化を目的とし、登録規則及び同細則の改正が 2019 年7月1日に予定されています。

この改正により、設備証書が廃止され、従来の設備証書に記載された内容は、新しい書式の船級証書に記載されることとなります。つきましては、同日以降に発行される船級証書の取扱い及び新証書の書式についてご案内申し上げます。

以下に概要をお知らせいたします。

1. 船級証書の構成及び記載事項

船級証書には船舶の基本情報(船名、国籍、総トン数、船級/設備符号および注記等)のみを記載し、その他の詳細情報(登録船主名、建造造船所、本船要目(LBD、主機)等)については、「付録(Appendix)」として記載し、証書に添付いたします。

詳細につきましては、添付の船級証書記載例を参照願います。


2. オンラインでの船級証書の有効性確認

今回の書式改訂にあわせ、船級証書の偽造防止を図ることを目的として、固有識別番号 (Tracking ID)及び QR コードによるオンラインでの証書有効性検証を実現いたしました。 証書有効性検証サイト (https://e-certificate.classnk.or.jp/CERF00010.aspx) にて IMO 番号 (対象船のみ) および証書下部に記載された 20 桁の「固有識別番号 (Tracking ID)」を入力いただくことで、当該証書の有効性をご確認頂けます。

- (1) 定期検査完了時
- (2) 船級証書及び/又は設備証書の記載事項に変更が生じ書換発行する場合
- (3) 船級証書及び/又は設備証書の再発行の場合

また、既存の設備証書については、新船級証書発行時に旧船級証書と共に弊会検査員が回収いたします。

なお、新船級証書へ書換発行されるまで、既存の船級証書及び設備証書は引き続き有効となりますので、引き続き本船上にて保管願います。
